

Building on Our Founders' Vision A Letter from the President

Dear Coalition Members, Supporters and Friends,

The Hungarian American Coalition has had a profound impact on our community through building bridges and strengthening ties between our two nations over the past 30+ years. In 1991, our 15 founders had an incredible vision that a coalition of dedicated individuals and established organizations could accomplish more when working together than individually.

We are deeply grateful for our generous supporters, partner organizations, committed members and program alumni. It has taken all of our efforts to create the impressive track record of the Coalition. Through three decades of dedicated HAC leadership, I have seen the best of both worlds—the can-do, ever optimistic outlook of Americans coupled with the creative passion, ingenuity and patriotism of Hungarians—come together to impact so many.

After years as a Board Member and serving as Vice President, I have been honored to serve as the Coalition President during several momentous anniversaries over the past several years: These include the 25th and 30th anniversaries of our Founding; the 60th and 65th anniversaries of the 1956 Hungarian Revolution; and the 100th Year of Remembrance of the tragic Treaty of Trianon.

In addition, during the past few years, we have all learned to navigate a global pandemic, which saw a seismic shift in not only what we do, but how we do everything. And now, we are faced with the War in Ukraine raging on the border of Hungary and deepening political divides on both sides of the ocean. It is so important for us to rise above the politics of the moment and maintain our independence and ability to work with all.



30th Anniversary Remarks Chairman of the Board, Csilla Grauzer

I am thankful to those Hungarian Americans who 30 years ago had the vision and determination to create the Hungarian American Coalition. Its unique programs, work on human rights issues, scholarships, training programs, Hungarian visitors, numerous cultural and educational programs, have truly made a difference in the lives of so many.

I have been fortunate to be part of the Coalition for several years and believe in its commitment to promote the interests of Hungarian Americans in a fair and unbiased way. The COVID-19 pandemic during the past two years brought uncertainty and great challenges. Our personal, professional and community lives all went virtual overnight and we truly entered into a new world of technology. Even in this new confounding environment, the great work of the Coalition went on.

The Coalition continued investing in the future through:

The John N. Lauer Leadership Training Program, a 4-month internship for young Hungarians in Washington D.C.;

The Dr. Elemér and Éva Kiss Scholarship Award—providing stipends at universities in the U.S.;

The Bognár Family Hungarian Scholarship Fund—providing stipends at universities in Hungary, the Subcarpathian region in Ukraine, Transylvania and the Vojvodina region in Serbia;

and presenting the "Hungarian American Coalition Award" to students at the Bolyai Farkas High School in Marosvásárhely, Transylvania.

During the pandemic, new platforms and "first ever" events were created, such as: the "Coalition Kávéház," a zoom series on community related topics; co-sponsorship of the documentary film "Mégis" about the Hungarian Human Rights Foundation (HHRF) and László Hámos; monthly calls with community leaders; numerous online community events, including the ITT-OTT meeting of the Magyar Baráti Közösség; virtual theatre sessions; monthly informal happy hour get-togethers; and many others.

The first ever Hungarian American Community Yearbook was published as a joint project between the Coalition, American Hungarian Foundation and Hungarian Hub, with more than 65 submissions. On December 4, 2020, the Coalition hosted the first ever Virtual Mikulás Gala, with the theme "Preserving our Past, Focusing on the Future," honoring Dr. Katalin Kádár Lynn.

The Hungarian Diaspora Council gives global community leaders an opportunity to meet and discuss common goals to preserve cultural heritage, identity and language.

The Kőrösi Csoma Sándor Program provides interns to aid diaspora communities with language classes, scouting activities, cultural events and to inspire the younger generation.

Thousands of books and documents were returned to Hungary thru the Mikes Kelemen Program. The Julianus Program is a database that maps Hungarian materials and locations in the U.S.

In 2020, Andrea Lauer Rice, U.S. President of the Diaspora Council, attended the virtual 10th Annual Diaspora Council meeting, delivering a video showcasing the events and activities of the Hungarian American Community in which several other Coalition members participated.

Since its founding the Coalition has worked with the Hungarian Human Rights Foundation (HHRF), to organize educational human rights workshops. In 2021, I was fortunate to attend one such workshop held at the Bercel Castle in Hungary that brought together ethnic Hungarians from Romania, Serbia and Slovakia, students and young professionals active in minority affairs and participants of HHRF's ReConnect Hungary cultural immersion program. Meeting so many bright young people committed to improve the lives of others gave me hope for a better future.

The issue of human rights is very close to my heart. Growing up in Transylvania, Romania during Ceausescu's brutal dictatorial regime, I experienced ethnic discrimination and persecution for simply being Hungarian. Serious human rights violations are still taking place and need to be addressed, so I applaud the work of the Coalition and HHRF for being a voice for those experiencing injustice.

It has been an honor to serve as Chairman of the Board of the Coalition in our 30th anniversary year. I am continuously inspired by so many of our Board members for their resilience and dedication to our common cause and to each other. Let's increase our efforts to reach even more people with our message of working together on our unique programs!

Looking Back on Three Decades Chair Emerita, Edith K. Lauer

As I think about the birth of our Hungarian American Coalition 30 years ago, I remember the tremendous excitement we felt then. Not only at the actual founding of the organization, but hearing and reading about the almost unbelievable changes in our homeland. Our beloved Hungary was finally a free country—in 1989, 1990 that seemed a miracle!

The small group of Hungarian American leaders who gathered in the Washington D.C. area to discuss how our community could help Hungary transform into a democratic, free market society, recognized the need for a new organization. Rev. Imre Bertalan, Zsolt and Szabolcs Szekeres, Gyula Várallyay, Sándor Taraszovics, Árpád Kovács, August Molnar, Paul Teleki, Edward Chaszar, Frank Koszorús Jr. , Paul Fekete and others: they wanted to build a Coalition of equal partners—hence our name—to pull together under one umbrella as many of the effective, active organizations as possible. We also recognized that building a viable organization must have the support of individual members. Thus, on August 20th, 1991, fifteen organizations and five individuals formally registered the Hungarian American Coalition in Washington D.C.

What were our goals?

to identify and promote the concerns of the Hungarian-American community;

to protect and preserve human and minority rights and cultural heritage of Hungarians;

to support democratic institutions and economic development in Hungary;

to encourage cultural and educational interaction between the people of the U.S. and Hungary;

We established an office of communication in Washington where the Szekeres brothers—Szabolcs, Zsolt and János gave us a room in their offices on Connecticut Avenue, two blocks from the White House, until we raised enough money to pay rent.

Our First Year

Even as a fledgling volunteer organization with little funding, in those first years we undertook many projects: we sponsored a six part Hungary—A Video History; assisted with the multi-city Kolozsvár Kollégium Choir Tour; published a Directory of U.S. university programs where Hungarian students could study; and we started a White House Internship Program and often hosted visitors in Washington from Hungary, Romania, Slovakia and Vojvodina. We worked hand in hand with László Hámos, Emese Latkóczy and Bulcsú Veress of the HHRF in calling

attention to human rights violations of the Hungarian minority communities in these countries. In 1995 we co-sponsored a full-day conference with the Potomac Foundation entitled "Promoting European Security and Integration: The Role of National Minorities." A comparison of minority rights of the Catalans in Spain and the Rato Romansh of Switzerland with those of Hungarians in Slovakia, Romania, Subcarpathia and Vojvodina offered a stark contrast.

Together with member organizations we held Human Rights Workshops in Cleveland, San Francisco, Hartford, Pittsburgh and elsewhere to inform and train young Hungarian-Americans about human rights in general, and the rights of Hungarians in particular. László Hámos, András Ludányi, Géza Kádár and Frank Koszorús were some of the instructors at these workshops. At the Hartford workshop I met for the first time an outstanding young man, Max Teleki, who would end up serving as President of our Coalition a decade later.

NATO Advocacy—A Milestone for the Coalition

In 1992, we joined a group called Central and Eastern European Coalition (CEEC) that claimed to speak for 20 million U.S. citizens of CEE background. President Clinton and VP Gore's foreign policy strategy was to assure stability in Europe through a revitalized NATO Alliance with rapid membership for the Visegrád countries.

Between 1994 and 1997, members of our Coalition were invited to five meetings on

North Macedonia Joins NATO

NATO expansion with President Clinton and/or Vice President Gore, Sandy Berger, Deputy Assistant to the President for National Security and Deputy Secretary of State, Strobe Talbott, and my favorite, Daniel Fried, Director of ECE for the National Security Council. Péter Újvági, a Councilman in Toledo, was instrumental in establishing a close working relationship between the Coalition and the White House.

In 1994, in an especially memorable meeting, Strobe Talbott said to the 20 CEE representatives: "The question is, what kind of Russia will we have in the 21st century? You feel Russia will revert to type and foresee a dangerous scenario; we see Russia more positively and do not want to undercut those forces which are building a benign democratic system." His comment was greeted by a stunned silence. Then Jan Nowak, the highly respected leader of the Polish American Congress stood up and said: "If you do not accept our opinion, why did you invite us here? And what will happen if WE are right, Mr. Secretary, and YOU are wrong?" Jan is long gone, but his words were prophetic.

In 1997, in order to inform the Hungarian public before a referendum on NATO membership, the Coalition held conferences in three Hungarian cities—Budapest, Debrecen, and Miskolc, entitled "Hungary in an Expanded NATO: Benefits and Responsibilities." Many experts and officials were invited to speak at the extremely well-attended conferences. Zsolt Szekeres, Anne and Joseph Bader accompanied our small group in each city. In the November referendum 85% of Hungarian voters favored NATO membership. And in 1999, Poland, Hungary and the Czech Republic became members of NATO.

Meeting Heroic Hungarians from Across the Region

Although the NATO conferences gave us high visibility, every project we organized affected our thinking. We had the opportunity to meet and work with heroic, outstanding people on their trips to the U.S.: Bishop László Tőkés, Miklós Duray, András Sütő, Sándor Csoóri, László Dobos, Sándor Sára and Imre Pozsgay just to mention a few.

In the spring of 1991 Transylvanian Bishop Kálmán Csiha visited the U.S. He brought first-hand information of the genuine needs of Transylvanian Hungarians whose schools were systematically confiscated by the Romanian government. Together with his niece, Kuni Nádas, they made a plan to establish a system of "Godparents" involving Hungarian Americans as sponsors, to support the education of young Hungarians as well as fund the rebirth of the Hungarian educational system in Romania. This is one of the most successful and long standing programs in our community. I am truly glad to be able to report that in 2000, after a lot of behind-the-scenes work by the Coalition as well as others, the 450 year-old building of the Kolozsvár Reformed Kollégium was returned to its rightful owners.

Through the years our Coalition always tried to develop a good working relationship with both U.S. and Hungarian Ambassadors. Once, we were invited to State and asked by the newly named U.S. Ambassador whom we would recommend for Deputy Chief of Mission. So many people wanted to be posted to Hungary, that he needed our advice. Without hesitation Zsolt Szekeres named the person, and he was soon appointed DCM.

As the Coalition celebrates its 30th anniversary, there are so many friendships and supportive relationships to list. George Pogan and Géza Kádár became fast friends in Budapest in 1989 just as communism fell. They have served as Secretary and

Legal Advisor respectively at the Coalition. Many Honorary Consuls joined us, among them Helen Szablya, László Bőjtös, Eugene Megyesy Jr., Csilla Grauzer, Éva Voisin, Katalin Pearman and others. The MBK—Hungarian Communion of Friends, the Cleveland Hungarian Heritage Society, the Hungarian Cultural Society of Connecticut, the Magyar Club of Chicago and others have played integral parts in our projects and development.

I am grateful for the financial support of those who have made our many projects possible: The Hungary Foundation, the Charles and Lisa Simonyi Fund, Dr. Charles Simonyi, the Pannonius Foundation, Centene Charitable Foundation, Ameritech, the Doris Buffet Foundation and our many generous individual donors.

I am sure I am not alone in feeling that our lives have been greatly enriched by serving a common cause greater than ourselves. Together with my husband, John, we traveled often and much to Hungarian-inhabited regions, and were truly inspired by so many of the people we met.

Even after 30 years much work remains to be done. I am deeply grateful for the privilege of being a part of the Coalition, and genuinely proud that my daughter, Andrea continues to build the organization into the future.



From 2012 to 2022, the Coalition provided 139 college scholarships to Hungarian students in the Carpathian Basin, 75 scholarships for Hungarian students to attend university in the U.S. and 68 unique, 4-month internships for young Hungarian professionals in Washington D.C. Since our founding in 1991, HAC has a growing network of more than 550 scholarship and internship program alumni.

The John N. Lauer Leadership Training Program

John N. Lauer (1939–2018) was a long-time generous supporter of the Coalition who served on numerous non-profit boards and demonstrated a strong commitment to higher education scholarships. In 1963, he married Edith Kish, an emigrant from Hungary, and gained much first-hand knowledge of his wife's homeland through dozens of visits to the region over the years. For his active support for many Hungarian causes and organizations, he was named an Honorary Hungarian in 1993 by then Hungarian Ambassador Pal Tar. In 2018, the Coalition Internship Program was renamed the "John. N. Lauer Leadership Program" (LTP).

The LTP is a unique internship program that directly links with the vibrant Hungarian American community and matches interns with local D.C.-based mentors. Participants gain hands-on experience in American political culture and civil society, establish valuable contacts in their chosen field, and are motivated to enter public service once they return to their country of origin. For the past several years, the LTP has been primarily funded by the Hungary Foundation and Pannonius Foundation.

Between 2005–2022, 99 students have completed the Coalition's John N. Lauer LTP. The years 2020–2022 were affected due to the pandemic. We are excited to announce Csendike Somogyvári will be our 100th LTP intern working at the Victims of Communism Memorial Foundation in 2023.

The Dr. Elemér and Éva Kiss Scholarship Fund

Dr. Elemér Kiss (1909–2000) and Mrs. Éva Kiss (1913–2008) left Hungary after the 1956 Hungarian Revolution, settled down in Maryland, and became founding members of the Coalition in 1991. Dr. Kiss held a JD from Pázmány Péter University and a MS in Library Science from Catholic University, while Mrs. Kiss held a degree in pharmacology from Eötvös Loránd University and bravely used her skills as pharmacist in Budapest to help wounded freedom fighters in 1956. Dr. and Mrs. Kiss were strong believers in the importance of higher education, because they had experienced firsthand that their educational backgrounded had helped them start over in a new country when they had little else.

In 2008 the Coalition renamed its Scholarship Fund to "The Dr. Elemér and Éva Kiss Scholarship Fund" to honor the legacy of Dr. and Mrs. Kiss's dedication to education. To date, more than 148 outstanding Hungarian students have benefitted from these scholarships, some across multiple years.

The Bognár Family Hungarian Scholarship Fund

Professor Dr. Béla Bognár (1931–2019) was born in Pakod, Hungary. From October 23 to November 9, 1956, he was part of a small group that fought against the Russians on the streets of Budapest. On November 11, he left Hungary, and headed for Belgium to start a new life. There, he graduated magna cum laude with a BS from Ecole Social de Louvain. After immigrating to the U.S., he obtained MS and Ph.D. degrees in gerontology, health and mental health policies from the University of Wisconsin. Over the next few decades, Dr. Bognár would teach, publish and serve as an advisor in the fields of social work and aging and receive numerous awards, including the Knight's Cross of the Order of Merit.

Remember, my little Béla, what I repeated to you throughout these years: "what you do for others, gives meaning to your life."

When honored for his life-long work in supporting Hungarian students in need in 2017, Dr. Bognár recalled inspirational words said to him by his grandmother when he left Hungary in 1956: "Remember, my little Béla, what I repeated to you throughout these years: what you do for others, gives meaning to your life."

Dr. Béla and April Bognár established the Hungarian Scholarship Fund (HSF) in 1999, to help outstanding Hungarian students finish their education in either their home countries, and to remain in or return to their home countries to provide leadership in their communities. In the spring of 2014, the Bognárs requested the Coalition to become the administrator of their HSF fund as part of the Coalition's comprehensive educational portfolio. The HSF was renamed "The Bognár Family Hungarian Scholarship Fund" (BFHSF).

Since its inception, the fund has awarded more than \$700,000 to 271 Hungarian students in the U.S. and the Carpathian Basin raised from members of the Hungarian American community, churches, organizations, the Sunshine Lady Foundation, and most recently by the Ambassadors of the Future.

Support from the Ambassadors of the Future

Since 2017, the Ambassadors of the Future (AF) launched an inaugural fundraising Gala. Since then, they have awarded \$40,000 to the BFHSF.

The AF was founded in Los Angeles, CA, in 2017 by Adam Beres; his parents, Zsuzsa Pekarovics, MD, and Attila Beres, Ph.D., and many other community members. The organization is committed to two goals: to raise funds for the international education of intellectually gifted but financially challenged students and to raise funds for socioeconomically disadvantaged children coping with diabetes and obesity.

Hungarian American Coalition Award at Bolyai Farkas High School

In 2017, the Coalition signed a Memorandum of Cooperation with the Cultural Foundation for Transylvania (CFT), to implement cultural projects in Transylvania based on decisions made by the boards of both organizations. The Coalition began disbursing grants for cultural and educational purposes that year, and established the "Hungarian American Coalition Award" at the Bolyai Farkas High School. In 2019, the inaugural award was presented to three students for their outstanding academic achievements and community service.

Support for Educational Institutions

The Coalition has helped support various educational institutions.

Dévai Szent Ferenc Alapítvány

In 2016 the Coalition approved institutional support for father Csaba Bőjte's Dévai Szent Ferenc Alapítvány, a Hungary-based foundation supporting Father Csaba's orphanages in Romania.

Bethlen Gábor College of Nagyenyed (Aiud, Romania)

Also in 2016 the Coalition approved institutional support for Fűzfa Egyesület, an association in Romania whose goal is to establish an endowment fund to support the Hungarian-language Bethlen Gábor College (BGK) of Nagyenyed (Aiud), Romania, through donations and sponsorships. Many students from the surrounding region opt for a local Romanian school for financial reasons. Educational expenses put a heavy financial burden on most families, because living in the diaspora usually also means a life of financial hardship. Students facing such hardship can attend Bethlen Gábor College only if they receive some form of subsidy, and the Bethlen Gábor Fund regularly grants such scholarships to poor children.

Funding Renovations at Semmelweis University

In 2013 the Coalition funded the reconstruction of the Department of Hematology at the First Department of Medicine of the Semmelweis University in Budapest with a grant of \$180,000 from the Charles Simonyi Foundation for the Arts and Sciences.



Commemorating the 1956 Revolution

Over the past 10 years, Hungarians everywhere have commemorated both the 60th and 65th anniversaries of the 1956 Revolution in Hungary. Since so many Coalition founders and leaders participated in the Revolution and later emigrated to the U.S., this is an important national holiday to both celebrate and commemorate and of course, pass on to the next generation.

65th anniversary

To commemorate the 65th anniversary of 1956, the Coalition unveiled a new "Hungarian Freedom Fighter" statue in Atlanta, GA, partnering with the Honorary Hungarian Consulate of Georgia and the Millennium Gate Museum. Over two years, the Coalition raised more than \$150,000 from across the community to fund the initiative. Major donors included: The Catherine and Charles B. Rice Foundation, John and Edith K. Lauer, the Hungary Foundation, Barton and Andrea Rice, the Embassy of Hungary and Leslie L. Megyeri.

In 2021, the initial studio unveiling occurred at sculptor Stan Mullin's art studio in Athens, GA, where the 15-ton granite statue was created. The studio unveiling and 1956 exhibit was attended by more than 250 people, including 10 freedom fighters and their families, Hungarian Ambassador Szabolcs Takacs, Rodney Mims Cook Jr, President of the Millennium Gate Museum and Naomi King, Martin Luther King's sister-in-law.

On October 23, 2022, the statue was placed in its final location at the Millennium Gate Museum and Park in Midtown Atlanta, GA. More than 200 people attended the ceremony, including 15 freedom fighters and their families and Ambassador Andrew Bremberg of the Victim's of Communism Memorial Foundation. An accompanying exhibit and website were also created. The "Hungarian Freedom Fighter" will serve as a permanent reminder of the unsung heroes who waged a battle against communism and the Soviet Union.

60th anniversary

In October 2016, the Hungarian American community commemorated the 60th anniversary of 1956 with events organized across the U.S. to pay homage to and remind the world of the hope, courage and sacrifice of Hungarian freedom fighters.

On October 16, 2016, Coalition leaders, including President Max Teleki, Chair Emerita Edith Lauer and VP Andrea Lauer Rice, attended a ceremony organized by the Embassy of Hungary in Washington, D.C., to unveil the statue of the "Budapest Lad" (Pesti Srác), a life-size bronze statue depicting a Hungarian student from 1956 holding the flag of the Revolution.

The next day the Embassy of Hungary and various Hungarian American organizations together opened a commemorative exhibition on 1956 at the U.S. Capitol. Speakers at the opening included Ambassador of Hungary Dr. Réka Szemerkényi; Chairman of the Board of the American Hungarian Federation Ferenc Koszorús; President of American Hungarian Heritage House Stefan Fedor; President of the Coalition Maximilian Teleki, the Honorable Miklós Seszták, the Honorable Dr. János Horváth, Chief Advisor to the Prime Minister of Hungary and 56er Dr. Jenő Megyesy, President of the Danube Institute John O'Sullivan, and Executive Director of the Victims of Communism Memorial Foundation Marion Smith.

Digitizing 56 Stories:

Personal Recollections of the 1956 Hungarian Revolution

Also in 2016, the Coalition digitized the English version of the book 56 Stories: Personal Recollections of the 1956 Hungarian Revolution, A Hungarian American Perspective, a collection of 65 stories consisting of personal testimonials of witnesses to the revolution and recollections from relatives of '56ers. Originally published in 2006, the book serves to ensure that not only the personal stories, but also the spirit of 1956 is passed on to future generations.



On October 23, 2022, the Coalition dedicated the Hungarian Freedom Fighter statue at Midtown Atlanta's Millennium Gate Park to the Freedom Fighters of the 1956 Hungarian Revolution. A crowd of 250, including 15 freedom fighters and their families witnessed the unveiling of the nine-foot statue, made of keyblue granite from Elberton, GA.

Rodney Mims Cook Jr., the founder of Millennium Gate Museum and Park, said the Park narrative highlights the virtues of peace, justice and freedom and the world-class sculpture demonstrates just that. The Hungarian Freedom Fighter statue will be an important historical addition to the park narrative and ensemble on 17th Street

"She not only reflects the courage and freedom of the Hungarian nation but is a beauty in her own right." Cook said. "The Hungarian gift will add to the urban landscape of our community and draw even more visitors to Millennium Gate Park."

"That was an emotional moment, the unveiling of the statue, because so many Hungarian Americans here have memories of either being there in 1956 and experiencing that revolution, or being the children of parents who experienced it and came to the United States as refugees, so it is equally emotional to me to see this unveiling. I know many in this community and there were some tears in their eyes that made me feel the same way."

Memory Project Visual History Archive

The Memory Project, a Hungarian American visual history archive, is a community-wide initiative aimed at helping to document and record the personal stories of Hungarians who emigrated to the U.S. after the 1956 Hungarian Revolution or as displaced persons after World War II. More recently, they have expanded their outreach to include Hungarian Americans with fascinating stories about their upbringing and other unique interviews with Hungarians across the world.

The Memory Project was co-founded in 2015 by Andrea Lauer Rice and award-winning documentary filmmaker and Coalition member Réka Pigniczky, both daughters of '56ers. A year after its founding, the Coalition granted the initiative \$1,000 to support the Memory Project and has remained an enthusiastic supporter. Over the past several years, the Archive has provided materials and inspiration for a number of documentary films: "Cold Warriors" (Lövészek) in 2017 and "The Memory Project: 1956/2021" in 2021.

The Memory Project was presented with the Friends of Hungary Award in 2018.





Special Projects

Árpád Kallós Collection Donated to Coalition

In 2021, the Coalition accepted a donation of artworks by Árpád Kallós, a Hungarian portrait painter who lived and worked in the United States between 1921 and 1960. The collection of eight oil paintings and six drawings was donated to the Coalition by Brian R. Fahs, great-great grandson of the painter. The Coalition agreed to transfer the artwork to Hungary for donation to a suitable museum or other cultural institution.

Mégis (And Yet) documentary

In 2020, the Coalition co-sponsored the production of Mégis (And Yet), a documentary film about the Hungarian Human Rights Foundation (HHRF) and László Hámos directed by acclaimed director János Domokos. The film documents the heartfelt goodbyes of the Hungarian communities in New York and Budapest from László. HHRF's first actions are remembered by witnesses, archive pictures and video recordings.

Coalition Kávéház

In 2020, the Coalition established Coalition Kávéház, a Zoom series on community-inspired topics. Lecturers included Coalition Vice President and Head of the Neurology Department at Emerson Hospital, Dr. Ágnes Virga; Founder of International Cybersecurity Dialogue and Coalition Board member Anne C. Bader; John N. Lauer Leadership Training Program intern Károly Barabási; Coalition President Andrea Lauer Rice; Coalition member Elizabeth Vos of Magyar Marketing; 56er and Coalition Chair Emerita Edith K. Lauer; and 56er and former President of MEFESZ in Emigration, Gyula Várallyay.

Annual Chagrin Documentary Film Festival

The Chagrin Documentary Film Festival is dedicated to educating audiences and empowering talented filmmakers to tell their stories. The festival is a five-day celebration of the art of documentary film, at venues in and around the century village of Chagrin Falls, Ohio. This inspiring event draws audiences from all over the world to experience documentary films and the compelling art and culture they highlight.

Every year the festival features a special Hungarian Night organized by Coalition board member George Pogan of Chagrin Falls, OH, to celebrate the Northeast Ohio Hungarian American community. The Coalition has long been a proud sponsor of Hungarian Night festivities. Two documentary movies from Memory Project have been featured: Cold Warriors and The Memory Project: 1956/2021."

GENIUS Olympiad

With a grant of \$3,200, the Coalition supported the participation of two students in the 2017 GENIUS Olympiad, an international high school project competition that focuses on environmental issues. Organized by Terra Science and Education and hosted by the Rochester Institute of Technology, GENIUS Olympiad promotes a global understanding of environmental issues and the achievement of sustainability through basic science, arts, creative writing, engineering, design, and business development. It provides challenges and opportunities for high school students to instill in them the skills and knowledge needed to be the citizens, leaders, scientists, artists, writers, engineers, and policy makers of the future—agents who will promote and contribute to greater environmental sustainability throughout their lives.

ArtStart4u

In 2017, the Coalition supported the ArtStart4u talent center, an initiative headed by opera singer Levente Molnár, for the purpose of developing a "talent center" for Hungarian youth, with special attention to Hungarian children from the Carpathian Basin. The initiative has also organized classical music masterclasses in Hungary and Transylvania.

Cultural Foundation for Transylvania

The Cultural Foundation for Transylvania (CFT) was established in 1989 in Washington, D.C., by Ilona Győrffy, András Ábrahám and András Hanák. The foundation's purpose is to support Transylvanian cultural projects, such as art exhibits and performances, book and periodical publishing, and other forms of art, as well as to provide fellowships to support cultural endeavors in Transylvania.

After Mrs. Győrffy death in 2017, the Coalition signed a Memorandum of Cooperation with CFT, accepted the balance of their funds as a grant (\$114,000) and began disbursing the money in the form of grants for cultural and educational purposes in Transylvania.

Since then, the Coalition has helped fund several projects, including the relocation of an extensive library of materials related to the Holocaust in Transylvania and

Michael Neidorff: Donor Impact

(November 19, 1942-April 7, 2022)



Neidorff served as President and Chief Executive Officer of Centene Corporation, a government services managed care company based in St. Louis, MO, for more than 25 years. He was elected Chairman of the Board in May 2004. His leadership is credited with one of the most successful HMO turnarounds in the health-care industry. Named to Forbes Magazine's list of America's Best Big Companies, Centene has expanded to eleven states and has become a publicly traded corporation that manages the healthcare of hundreds of thousands of individuals.

Neidorff was actively involved in community and civic affairs. He served as Emeritus Trustee of the John F. Kennedy Center for the Performing Arts serving as the Co-Chair of the International Committee on the Arts and also on the Boards of Directors of several arts and cultural organizations such as St. Louis Symphony, Boy Scouts of America and Grand Center, Webster University, the Opera Theatre of St. Louis, the St. Louis Science Center, Trinity University in San Antonio, TX, and the National Children's Cancer Society.

His wife, Noémi Neidorff, is of Hungarian origin and is an active supporter of higher education initiatives, including the Hungary-Missouri Educational Partnership, a Coalition member organization. She also supports the George Kárpáti Lectureship at Drew University (NJ), which honors her father, the late George Kárpáti.

The team from Pécs investigated how migration health is integrated into the U.S. public health and social care systems.

Cultural Programs

Andrea Rost Concert

On May 29, 2014, the Coalition sponsored a concert by world famous soprano Andrea Rost at the Warner Theatre to celebrate the 25th anniversary of the fall of the Iron Curtain and the proclamation of Hungary as a free, democratic republic. The program included arias from well-known operas as well as Hungarian folk songs. Ms. Rost was accompanied by Hungarian Canadian pianist Gergely Szokolay; solo pieces by Bartók, Debussy, Rachmaninoff and R. Strauss.

The concert and gala dinner that followed were made possible by generous donations from The Hungary Initiatives Foundation, Centene Corporation, John and Edith K. Lauer and the Charles Simonyi Foundation for the Arts and Sciences.

Former Coalition member Bulcsu Veress' Jazz Music Collection and Publications

The late Bulcsú Veress (1941–2012) was a Hungarian-American political scientist and long-time Coalition supporter. In 2013, the Coalition managed the donation of Bulcsu Veress' estate, from which one of Hungary's largest jazz music recordings and publications was donated to the Liszt Ferenc University of Music, and an 800-book collection of political science books was donated to the Hungarian Human Rights Foundation.

Since 1967, the Smithsonian Folk Life Festival has a storied tradition of presenting international folk traditions on the Mall in Washington, D.C. In 2013, the festival featured "Hungarian Heritage: Roots to Revival." More than 100 folk musicians, dancers, artists and craftspeople from Hungary and ethnic Hungarian communities in the surrounding countries traveled to Washington D.C. to display their skills. Everyday, 50,000 to 150,000 visitors immersed themselves in rich and vibrant Hungarian folk heritage.

In 2013, the festival was funded in large part by a Hungarian government allocation of almost \$1 million. The Coalition raised an additional \$165,000, including an inaugural \$150,000 grant from the Hungary Initiatives Foundation (HIF). The Coalition worked closely with festival organizers (the Budapest-based Balassi Institute and its Director Pál Hatos; the Hungarian Cultural Center in New York City and its Director Dr. Ágnes Fülemile; and the Hungarian Embassy in Washington D.C.) to help maximize the event's reach and create a memorable experience for visitors. In addition to the organizations and their staffs, countless volunteers from throughout the Hungarian American community contributed to the festival's success.

Commemorations and Exhibits

1956 Exhibit at Millennium Gate Museum in Atlanta, GA

In October 2022, in addition to the "Hungarian Freedom Fighter" statue unveiling (on page 22–23), the Coalition created a 1956 multimedia exhibit that was displayed at the Millennium Gate Museum in Atlanta, GA. The exhibit included photographs, newspapers, artifacts and a short video from Memory Project. It was so successful in telling the story of communism that the Coalition was approached by MGM to expand the exhibit to include images from Prague Spring and the Solidarity Movement in Poland. It also highlighted the friendship between U.S. President Ronald Reagan and Pope John Paul II, which many experts credit with leading to the eventual fall of the Iron Curtain. The exhibit was captured digitally and is available at the www.HungarianFreedomFighter.com website.

Holocaust in Hungary exhibit

The "Holocaust in Hungary" traveling exhibit documented the tragic events that took the lives of 550,000 Jews in Hungary during the Holocaust. In January 2014, the Coalition co-sponsored its showing at the United Nations Headquarters in New York along with the Carl Lutz Foundation, Budapest; the Lantos Foundation for Human Rights and Justice and the Permanent Mission of Hungary to the United Nations. The exhibit was made possible by a grant from The Hungary Foundation.

In May 2014, the exhibit opened at the U.S. Congress in the Rayburn House Office Building, with additional support from the Embassy of Hungary in Washington, D.C.

Hungarian Cultural Center to relocate a collection of unique objects and photos from Vintondale, PA

In 2012 the Coalition provided a \$2,000 grant to the Hungarian Cultural Center to relocate a collection of unique objects and photos from Vintondale, PA, to the Hungarian Open Air Museum in Szentendre. The collection are on permanent display there, giving the most-detailed and authentic anthropological exhibit on the lives of first generation Hungarian Americans.

160th anniversary of Lajos Kossuth's 1851–1852 tour of the United States

In 2012 the Coalition supported the presentation of "Kossuth's Message" with \$500, commemorating the 160th anniversary of Lajos Kossuth's 1851–1852 tour of the United States.

INFORMATION & ADVOCACY

The Coalition launched a community-wide fundraiser and provided more than \$120,000 in humanitarian assistance to organizations on the ground in Hungary and Ukraine. The Coalition has raised awareness of human rights issues by organizing numerous trips to the region and to D.C. and operating an Office of Information in both Budapest and Washington D.C.

Preserving Human Rights

In the Hungarian American context, "human rights" issues have come to mean, first and foremost, the human rights of Hungarian historic national minorities that became national minorities in Romania, Czechoslovakia, Ukraine, and Yugoslavia as a result of the 1920 Treaty of Trianon. The Hungarian Human Rights Foundation (HHRF) was founded in 1976 by young Hungarian Americans in New York to give voice to their plight. The Coalition's leaders and members cooperate with and complement the HHRF's efforts to ensure that the continuing human rights concerns of Hungarian minorities remain at the forefront of international diplomacy concerning the countries of East Central Europe.

The Coalition's human rights advocacy is rooted in support for the legitimate, democratically expressed aspirations of the Hungarian minority communities themselves. To this end, the Coalition sponsors visits and conferences to enable minority leaders to explain their situation directly to U.S.-based officials, diplomats and experts; provides up-to-date, credible information to U.S. officials, diplomats and non-governmental organizations; maintains active ties with the leaders and activists in these communities; and meets with visiting officials and civil representatives from the region.

Since 2010 the Hungarian government's diaspora policies have undergone an unprecedented period of change and strengthening. One important step was the creation of the Hungarian Diaspora Council, which provides a forum of dialogue for representatives of the diaspora and representatives of the Hungarian government.

The creation of the Hungarian Diaspora Council was soon followed by the initiation of different programs tailored to engage Hungarian diaspora communities worldwide, such as the Kőrösi Csoma Sándor Internship Program and the Mikes Kelemen Program. Hungarian diaspora policy also supports birthright programs such as the ReConnect Hungary and Diaspora Camp.

Information & Advocacy Efforts

Since its founding, a primary goal of the HAC has been to provide Washington decision-makers with credible and timely information about important issues to its members. This includes monitoring human rights issues affecting the Hungarian communities of the region—primarily in Romania, Slovakia, Serbia and Ukraine. Activities include:

Operating an Information Office in Washington D.C. and Budapest, Hungary.

Staying in frequent contact with Hungarian community leaders in Romania, Slovakia, Serbia and Ukraine about events affecting the Hungarian communities of each region.

Coordinating activities and information with member organizations to stay abreast of human right issues and/or violations in Romania, Slovakia and Serbia.

Monitoring news and media reports on matters of interest to Hungarian Americans to share and exchange with the community.

Organizing a December White House Briefing to acquaint members with officials of the Administration, the State Department and the National Security Council.

In addition to keeping U.S. politicians abreast of human rights issues affecting the Hungarian communities of the region, the Coalition has worked closely with leaders from Washington both in Hungary and in the U.S. Here are some highlights from the past few years:

On October 27, 2020, the Government of Hungary inaugurated a statue of President George H. W. Bush at Liberty Square in Budapest. Coalition Treasurer Szekeres was present at the event and met with U.S. Ambassador to Hungary David Cornstein and Hungarian Prime Minister Viktor Orbán. Also in 2020, Andrea Lauer Rice gave interviews that appeared on Hajónapló, the Magyar Living Podcast and the Hungarian television news channel HírTV.

To commemorate the 63rd anniversary of the '56 Revolution and Freedom Fight and the 30th anniversary of the restoration of democracy in Hungary, the Embassy of Hungary in Washington D.C. held a National Day Reception at the John F. Kennedy Center for the Performing Arts Skylight Pavilion in October 2019. The event was attended by President Rice and other Coalition members.

At the Presidential Inauguration of President Donald Trump in January 2017, Coalition President Andrea Lauer Rice attended several events in the nation's capital including the "Salute to Freedom" Inaugural Brunch with other Coalition Board members at the new building of the Embassy of Hungary in Washington D.C. Later that year, Mr. Teleki met with officials at the State Department, the National Security Council and Congressional offices, as well as with Hungarian Ambassador László Szabó. Members of the Coalition also attended the official inauguration ceremony of the new building of the Embassy of Hungary in Washington, D.C. with Hungarian Minister of Foreign Affairs and Trade Péter Szijjártó and Ambassador Dr. Réka Szemerkényi.

In 2011, members of the Coalition Board participated in a series of events in Budapest, when Secretary of State Hillary Clinton, former Secretary of State Condoleezza Rice, and Congressman Tom Lantos visited Hungary. The next year, Coalition President Max Teleki met with staff from the Democratic National Committee, the Republican National Committee, and the Romney and Obama campaign teams. Mr. Teleki also participated in the Tom Lantos Institute's Executive Committee meeting and in the International Centre for Democratic Transition project and funding meetings, and he spoke at an event titled "Visions of America: The State of US Presidential Politics."

NATO Expansion

In the early 1990s, the Coalition led efforts in the Hungarian American community to promote the expansion of NATO, and to include Hungary in the first group of Central and East European countries asked to join the Atlantic alliance. HAC was an active participant in the Central East European Coalition's (CEEC) efforts in support of NATO expansion.

In 2014, the Coalition supported a letter to Secretary of State John Kerry, signed by 40 Members of Congress, supporting the expansion of NATO to include Macedonia and Montenegro. The letter was sent just prior to the 2014 NATO Summit hosted by the United Kingdom. Since then, NATO has expanded to include Montenegro in 2017 and North Macedonia in 2020.

Advocacy for Security in Central and Eastern Europe

NATO continues to play a crucial role in the region's security, especially in light of Russia's illegal invasion and annexation of Crimea and Eastern Ukraine in 2014, and again in 2022. These events have rallied the Central European Diaspora in the U.S. and the Coalition, as we continue to work on areas of security in the region with the CEEC. Together, we will continue to express our strong disapproval at Russia's expansionist policies and its disregard for international law in Ukraine and beyond.

Despite the current challenges between Hungary and the United States, we have far more that binds us together than separates us. The American and Hungarian people share an unwavering commitment to freedom and a shared vision of a free, sovereign, and united Europe at peace.

Anti-Communism Legislation

In a new advocacy initiative, the Coalition is working with the Victims of Communism Memorial Foundation on exhibits that educate on the history of communist ideology. As one example, HAC is cooperating with VOCMF to pass state legislation in Georgia to designate November 7th as Victims of Communism Day and to compel public schools to teach the next generation about the realities of communism.

Special Visitors

From time to time the Coalition facilitates the visiting of prominent Hungarian community leaders from the Carpathian Basin to the USA to meet with Hungarian diaspora community leaders and also U.S. political leaders to discuss issues important to both the Hungarian diaspora community in the U.S. and the greater U.S.–Hungary relationship. Moreover, the Coalition also supports the sending of its leaders to visit Hungary and its surrounding regions to meet with community leaders and politicians there.

Hungarians traveling to the United States (some highlights):

In both 2018 and 2019, in Washington D.C., the Coalition hosted Dr. László Brenzovics, the sole ethnic Hungarian deputy in the Parliament of Ukraine. Dr. Brenzovics, who is President of the Cultural Alliance of Hungarians in Transcarpathia, met with U.S. officials, policymakers and academic leaders and provided first-hand information on recent legislative measures that violate the rights of the Hungarian national minority in Ukraine.

In 2014, the Coalition arranged for Bishop László Tőkés' visit to Washington D.C. during which he met with U.S. officials and the leadership of the Coalition and the Hungarian Human Rights Foundation. He also gave interviews to Cleveland's Bocskai Radio and Magyar Távirati Iroda (MTI).

In 2011, the Coalition assisted in organizing the Cleveland visit of President of Hungary Dr. Pál Schmitt. Several Coalition leaders, including Coalition Chair Emerita Edith Lauer, Honorary Consul László Böjtös, and Ted Horvath, took active roles in organizing various events for Dr. Schmitt on his first U.S. visit as president. His itinerary included visits to St. Erzsébet Catholic Church, several Hungarian statues and the Hungarian Cultural Garden, a swearing-in ceremony for new Hungarian citizens hosted by Coalition members, the Cleveland Hungarian Heritage Society, and a festive President's Luncheon involving 160 people.

Regional Trips and Meetings

Coalition Leaders Visit Hungary and the Surrounding Region

An important part of the HAC President's job has been to gather first-hand, dependable information about the situation of Hungarian minority communities in the countries surrounding Hungary. To that end, HAC leaders have travelled on fact-finding trips to Romania, Slovakia, Serbia and Ukraine at regular intervals, sometimes multiple times a year, and have held meetings with leaders of the historic minority communities in these countries.

In 2019, several visits were made to the regions surrounding Hungary. In March, Coalition leaders Max Teleki and Zsolt Szekeres accompanied former Governor of New York George Pataki on a visit to Beregszász (Berehove), Ukraine.

Later that year, President Andrea Lauer Rice and Treasurer Zsolt Szekeres travelled to the Transylvanian region of Romania where they met with community leaders, including Bishop of the Transylvanian district of the Reformed Church in Romania Béla Kató; President of the Democratic Union of Hungarians in Romania (RMDSZ) Hunor Kelemen; Executive Director of RMDSZ Bálint Porcsalmi; and former deputy mayor of Kolozsvár Anna Horváth. They also met with members of Kolozsvár's Hungarian Human Rights Foundation's (HHRF) office. They gave live interviews on Radio Kolozsvár and on the television program Erdélyi Figyelő, and Lauer Rice later spoke in Hungarian at the graduation ceremony of the Bolyai Farkas High School in Marosvásárhely, presenting the "Hungarian American Coalition Award" to three students recognized for their outstanding academic achievement and community service.

In July, Zsolt Szekeres participated in a roundtable discussion again on Hungarian national policy at the 27th Transcarpathian Summer Open University (XXVII. Kárpátaljai Nyári Szabadegyetem) in Szinevirszka Poljana (Felsőszinevér), Ukraine. He also travelled to the 30th Bálványos Summer University and Student Camp held in Băile Tușnad (Tusnádfürdő), Romania (Transylvania), to attend a roundtable discussion on diaspora affairs.

Between 2017 and 2019, Andrea Lauer Rice met with Chargé d'Affairs of the U.S. Embassy Budapest David Kostelancik; Political Attache Erin Webster-Main; Ambassador David Cornstein and his staff; Minister of the Prime Minister's Office Gergely Gulyás; President of the Parliament's Committee on Foreign Affairs Zsolt Németh; President of the National Assembly of Hungary László Kövér; Director of the North American Department at the Hungarian Ministry of Foreign Affairs and Trade Eszter Sándorfi; Ambassador Ferenc Kumin; Director of the North American Department at the Hungarian Ministry of Foreign Affairs and Trade Ms. Zita Bencsik; Secretary of State for National Policy János Árpád Potápi; Ministerial Commissioner responsible for Hungarian communities abroad Péter Szilágyi; Head of Department at the State Secretariat of National Policy Judit Pirityiné Szabó and other government officials.

In July 2018, Zsolt Szekeres participated in a roundtable discussion on Hungarian national policy at the 26th Transcarpathian Summer Open University (XXVI. Kárpátaljai Nyári Szabadegyetem) in Szinevirszka Poljana (Felsőszinevér), Ukraine.

In November 2017, Andrea Lauer Rice spent two days in Berehove (Beregszász) and Uzhhorod (Ungvár) to learn more on the situation of the Hungarian minority in Ukraine. She met with President of President of Cultural Alliance of Hungarians in Sub-Carpathia (KMKSZ) and former Member of the Ukrainian Parliament László Brenzovics; Rector of the Ferenc Rákóczi II. Trancarpathian Hungarian Institute Ildikó Orosz; and Government Commissioner István Grezsa.

In October 2015, a memorial was held for Hungarian writer and politician László Dobos in Királyhelmec, Slovakia. A statue of Dobos was unveiled by Coalition Chair Emerita Edith Lauer among others. On behalf of the Coalition, Zsolt Szekeres, Edith Lauer, Katica Avvakumovits and John Lauer paid their respects and laid wreaths at László Dobos' statue.

Over the last 10 years, Coalition Presidents Max Teleki and Andrea Lauer Rice have made several annual visits to Hungary and the region to meet with government officials, members of parliament, opposition leaders, civic groups and the media. They also gave interviews and participated in events and meetings with Hungarian leaders in the surrounding countries. During their visits, they also took time to meet with Coalition's John N. Lauer Leadership Training alumni.

Between 2012 and 2016, President Teleki met with the Board of the Tom Lantos Institute; U.S. Ambassador Eleni Kounalakis and her staff; U.S. Ambassador Colleen Bell and her staff; President of the Hungarian Parliament László Kövér; Minister of Foreign Affairs János Martonyi; leaders of the Foundation for a Civic Hungary and the Antall József Knowledge Center; Vice President of the Hungarian Parliament Gergely Gulyás, President of the Parliament's Committee on Foreign Affairs Zsolt Németh; Director, Foreign Affairs, Office of President János Áder László Szőke; Personal Assistant of President Áder Károly Szadai, Judge of Hungary's Constitutional Court Dr. István Stumpf; Minister of State for Economic Diplomacy, Ministry of Foreign Affairs and Trade Levente Magyar; Deputy Minister, Ministry of Human Capacities Bence Rétvári; and other government officials. Lectures were organized at the Antall József Knowledge Center, the Széll Kálmán Foundation and the Central European University on current political developments in Hungary and the United States. Meetings were also held with U.S. embassy officials, leaders of Hungary's business and academic community, and the Federation of Jewish Communities.

Overview of Publications

Statements and Position Papers

When matters of special significance arise, the Coalition issues official statements to keep members and public opinion apprised of the organization's official position and perspective:

In February 2022 the Coalition issued a statement condemning in the strongest possible terms the Russian invasion of a free and democratic Ukraine.

In June 2020, the Coalition published an English-language video statement with Hungarian subtitles on the 100th anniversary of the Treaty of Trianon.

In May 2015, Coalition President Maximilian N. Teleki issued a statement to present the Coalition's position on U.S.—Hungary relations and to clarify any misunderstandings stated in the press about what kind of organization the Coalition is and how it operates as a fully independent advocate for a positive U.S.—Hungary relationship.

In 2012, the Coalition issued a statement expressing a strong objection to the politically motivated decision made in Sepsiszentgyörgy (Sfântu Gheorghe), Romania, to renationalize the Székely Mikó Reformed High School. The decision reversed the historically proven ownership of a Hungarian institution; it unjustly sentenced two Hungarians: Attila Markó and Tamás Marosán to prison sentences for carrying out their duty; and it represented a major step backward in the long-overdue process of church property restitution in Romania.

In February 2012, the Coalition issued a statement titled "Give Hungary a Chance," in which Coalition members voiced their concerns over the harsh criticism in the mainstream U.S. and European media towards the Hungarian government.

Humanitarian Assistance

The HAC has played a major role in humanitarian assistance projects in Hungary. Below are some highlights:

Devecser Music School

The HAC also approved five grants to assist in the rebuilding efforts near Devecser, which was greatly affected by disaster. The grants went towards the following: purchasing new musical instruments for the Devecser Music School; co-financing the rehabilitation of the school's roof; employing a school psychologist for two years to attend to the schoolchildren; employing a full-time Roma social worker to help the school teachers with mentoring and providing support services; and funding the cost of a full-time internship program for two years, which placed bilingual Hungarian-American volunteers to help the mayor's office network with potential investors, assist with development programs, and provide administrative support.

Kárpátalja Aid Initiative of the Hungarian Maltese Charity Service

In 2015, the HAC donated \$10,000 to the Kárpátalja Aid Initiative of the Hungarian Maltese Charity Service, spearheaded by its President Imre Kozma, Hungary's First Lady Anita Herczegh, and the Hungarian Scout Association of Sub-Carpathia. The initiative assists the civilian population in Sub-Carpathia (Western Ukraine).

Hungary Foundation: Donor Impact



Founded in 2013, the Hungary Foundation (Hungary Initiatives Foundation) creates lasting value by reviving and strengthening the cultural and educational bonds between the U.S. and Hungary.

HF and the Coalition have partnered on many projects:


- In 2013, as one of its initial projects, HF worked with the Coalition to provide a large contribution to the Smithsonian Folklife Festival in Washington D.C. to present Hungarian arts and culture.
- In 2014, HF helped sponsor the "Holocaust in Hungary" traveling exhibit. It was shown at the United Nations Headquarters in New York and the Rayburn House Office Building at the U.S. Congress.

- For the past nine years, the Foundation was the primary sponsor for the Coalition Internship Program (CIP). In 2018, CIP was renamed the John N. Lauer Leadership Training Program (LTP). The current HF Executive Director, Anna Lacey Smith, is an alumna of the CIP.
- HF was a sponsor of several HATOG (Hungarian Americans Together) Conferences attended by dozens of Hungarian American leaders in Atlanta, GA, Boston, MA, Sarasota, FL and Washington D.C.
- HF also provided grants to Memory Project: Visual History Archive, an important community project the Coalition actively supports.
- In 2022, HF became a "Patron of the Arts" sponsor of the 1956 Hungarian Freedom Fighter statue unveiled in Atlanta, GA.

Ukraine Relief Fund

On February 25, 2022 the **Hungarian American Coalition** joined the international community in condemning the Russian invasion in Ukraine and immediately started fundraising efforts to assist Hungarian and Ukrainian refugees escaping war-torn Ukraine. With the generous support of individuals and organizations, the Coalition has raised more than **\$115,000** since February 25 and supported the following projects and initiatives:

- \$10,000 in immediate aid to refugees to the Hungarian Maltese Charity Service (Magyar Máltai Szeretetszolgálat).
- \$5,000 in immediate aid to refugees to the Hungarian Interchurch Aid (Magyar Ökumenikus Segélyszervezet).
- \$5,500 in aid of local relief efforts to a consortium of mayors in Hungarian villages bordering Ukraine.
- \$5,500 to facilitate the further delivery of donations and goods by the Carpathian Foundation (Kárpátok Alapítvány) in cooperation with its sister organizations in Slovakia and Ukraine and \$14,250 to purchase and deliver an ambulance to Uzghorod, Ukraine.
- \$20,500 in partnership with the Hungarian (Magyar) Club of Chicago to the local government of Bakonybél to house and care for refugee families.
- A mobile pediatric inpatient unit donated to the Odesa Rehabilitation Hospital manufactured by a Hungarian company, Continest that cost \$44,000 with shipment to Odesa made possible by a \$32,000 grant from the Hungarian Human Rights Foundation (HHRF) and other generous donors of the Coalition, facilitated by the Carpathian Foundation.
- \$4,000 to cover the shipment cost of medical supplies donated by the
 Creative Cultural Exchange, Inc. (1690 boxes of products worth \$200,000)
 from the U.S. to Hungary that will be distributed by the
 Hungarian Interchurch Aid.
- Cultural Alliance of Hungarians in Sub-Carpathia (Kárpátaljai Magyarok Kulturális Szövetsége—KMKSZ)—\$5,000 to assist with a program delivering medications and medical care to local Hungarians who are severely ill or disabled.

HUNGARIAN AMERICAN COMMUNITY AFFAIRS

The Coalition has hosted 16 annual Galas and 28 annual Mikulás Dinners that have become a Washington tradition for leaders seeking to make a difference in Hungarian American relations. The Coalition has spearheaded 10 regional conferences, enabling the community to connect and collaborate.

Annual Mikulás Dinners

Since its founding in 1991, every December in the spirit of the Hungarian Mikulás tradition, the HAC has thanked its supporters by organizing a Mikulás Dinner. In total, nine different Hungarian Ambassadors have hosted the events, which have featured a number of prestigious speakers, including the Hungarian President and Prime Minister on separate occasions. The evening also honors the HAC's friends and members and has featured countless musical performances and the long-time tradition of ending the evening with the singing of Christmas carols.

2022

Keynote Speaker: Ambassador Andrew Bremberg, President of the Victims of Communism Memorial Foundation

Ambassador Bremberg reflected on the importance of preserving and protecting freedom. He described that Europe and the West is "falling into a sense of nihilism losing a sense of belief in ourselves, in our own goodness, in our shared values and in the importance of freedom."

Keynote Speaker: The Honorable Zsolt Németh, Chairman of the Hungarian Parliament's Committee on Foreign Affairs

Keynote Speaker: Hon. Zsolt Németh, Chairman of the Hungarian Parliament's Committee on Foreign Affairs

On the night before the dinner, the Kossuth Foundation and Embassy of Hungary organized a plaque dedication ceremony at the Kossuth House, to celebrate 30 years of freedom in Hungary. After speeches from HAC board member and Chairman and Executive Director of the Kossuth House Gabe Rozsa; Ambassador Dr. László Szabó; and Chairman of the Hungarian Parliament's Committee on Foreign Affairs Zsolt Németh, a flag flown over the Hungarian Parliament was presented, along with a letter from the Speaker of the Hungarian National Assembly László Kövér.

The next day at the Mikulás Dinner, Mr. Németh mentioned the upcoming 100th anniversary of the Trianon Peace Treaty and the importance of national cohesion, which transcends borders. He expressed admiration for how the late Hungarian Human Rights Foundation (HHRF) President László Hámos, current HHRF President Zsolt Szekeres, members of the Hungarian American Coalition and the Kossuth House, and all Hungarian organizations in the U.S. work and live for the idea of uniting the nation across borders. 2018

Keynote Speaker: The Honorable Damon Wilson, Executive Vice President of the Atlantic Council

In his remarks, Mr. Wilson expressed his dissatisfaction with the current state of the alliance between the United States and Hungary, and talked about the reasons why he identifies with a strong sense of identity and spirit of the Hungarian-American community. Mr. Wilson then laid out several guiding principles and possible solutions on how to bolster the U.S.-Hungarian alliance, including deepening the understanding between the two nations, and forging a strategic partnership based on common values and goals. He added, "Hungary has made it clear that it is part of the West not just by culture, but by choice—in 1848, 1956, and 1990."

2017

Keynote Speaker: Ambassador Kurt Volker, U.S. Special Representative for Ukraine Negotiations

Ambassador Volker began his address by remembering his time in Hungary during the preparation for NATO membership and the Bosnian War, during which Hungary was a reliable partner of the U.S.. Next, he listed some challenges that the entire transatlantic community faces today, both domestic and foreign. To address these challenges, he said that we need to know who we are, take a stand, recognize that not all who do not belong to us are our enemies, hold our leaders accountable, and finally be patient. As Hungary and the U.S. are friends, to deal with the challenges, they have to face the real enemies and not those whom we perceive to be.

In a surprise award ceremony, HAC Chair Emerita Edith K. Lauer recognized former Deputy Chief of Mission of the U.S. Embassy in Budapest and Ambassador Thomas Robertson on behalf of the Board of Directors of the HAC "for representing the best traditions of American diplomacy during Hungary's historic transition and beyond."

2016

Keynote Speaker: The Honorable Dennis Ross, U.S. Representative (R-FL) U.S. Representative Dennis Ross delivered his address praising the Hungarian Ambassador's intellect and passion for freedom, which strengthen the bond with Hungary. He added, "the future now is brighter than it has ever been for American–Hungarian relations." Representative Ross also expressed the importance of Hungary's strategic role for the U.S. as he sees Hungary as a leading country in Europe acknowledging its immigration policy. He concluded his remarks by highlighting the significance of educating younger generations about their heritage and encouraged the community to celebrate together and to never forget their homeland or origins.

After the keynote remarks, former Coalition Presidents Edith Lauer and Zsolt Szekeres presented an award to Max Teleki, in which the Board conferred him the title of President Emeritus in recognition of his outstanding contributions as HAC president for the last 12 years.

2015

Keynote Speaker: Mr. Zsolt Németh, Chairman of the Hungarian Parliament's Committee on Foreign Affairs

In his address Mr. Németh said he felt the Hungarian American question has become overshadowed by security concerns. He stressed the importance of preventing a power vacuum in the world through a strong U.S. presence in and relationship with Europe and credited Russian President Putin with strengthening NATO's resolve. Later, Mr. Németh highlighted the importance of the upcoming 60th anniversary of 1956, for which Hungarians can express their gratitude to the freedom fighters and also to all the nations who showed solidarity and provided a new home to Hungarians. Referring to the current state of the relationship between the two nations, Mr. Németh declared that "the love of freedom is what brought this marriage together."

2014

Keynote Speaker: Dr. György Schöpflin, Member of the European Parliament and the European People's Party

Ambassador György Szapáry and Mrs. Enikő Molnár Basa Receive Coalition Awards In his keynote address, Dr. Schöpflin acknowledged that the current bilateral relationship between the U.S. and Hungary has serious problems, which are based partly on concrete issues, but are also a matter of perception. He also pointed out that all democratic countries are different, including Hungary, which means that it will never practice democracy in the exactly the same way as does the U.S.. According to Dr. Schöpflin, "the world has its Hungarian version [of democracy]. and it is not worse than anyone else's."

At the dinner HAC President Maximilian Teleki presented two special awards: the first honored outgoing Ambassador Szapáry for his devoted service in advancing the friendship between the peoples of Hungary and the United States in the spirit of the 1956 Hungarian Revolution, and the second recognized Mrs. Enikő Molnár Basa for her many contributions to the success of the HAC's Congressional Internship Program, in her role as the interns' "quardian angel."

He also announced the creation of a U.S.-based foundation whose mission will be to strengthen ties between Hungary and Hungarian–American communities. Specifically, its goal will be to establish a framework of cooperation, in effect, creating a kind of "outreach program" that would extend to the Hungarians of North America. Dr. Fellegi underscored that for the first time since the fall of communism, a Hungarian government is making an earnest effort to engage Hungarians worldwide.

HAC Community Intiatives

The Coalition is dedicated to supporting initiatives that further promote the interests of Hungarian Americans. These initiatives help to preserve Hungarian traditions and reinvigorate the diaspora by bringing together leaders from both the Hungarian American community and the Carpathian Basin.

Hungarian American Community Yearbook on 2020

In 2020, the HAC proudly announced the publication of an English-language Hungarian American Community Yearbook. This new initiative was a collaboration between the HAC and two of its member organizations: the American Hungarian Foundation and HungarianHub. The yearbook summarizes the unprecedented challenges of 2020 and how the Hungarian American community as a whole responded with new and innovative community activities and resources.

Overall, the book is divided into seven sections (Churches, Schools, Organizations, Community Houses, Cultural Initiatives and Honorary Consuls), and comprises reports from 72 organizations. The initiative was publicized for many months across the community in an attempt to reach as many people as possible, and submissions were open to anyone interested.

Saint Stephen of Hungary Pilgrimage

From 2016 to 2019, the HAC attended and co-sponsored a short pilgrimage to the Our Lady of Hungary Chapel around the Day of Saint Stephen, August 20th, in Washington D.C., which is followed by a traditional Hungarian picnic. In 2016, the pilgrimage was attended by Father Csaba Bőjte, a Franciscan monk and founder of the Children of Saint Francis Foundation of Déva (Romania).

Hungarian Picnic

The semi-annual Hungarian Picnic in Rock Creek Park in Washington D.C., is co-organized by HAC Board Member Enikő Molnár Basa. The goal of this event is to bring together Hungarian American residents, Hungarian students and young professionals in the Washington D.C., area twice a year for an afternoon of fun, food, music and networking. Leaders and interns of the Coalition, including Coalition President Andrea Lauer Rice in 2019, have sponsored and attended this event multiple times to show their support.

Hungarian Charity Ball in the Washington D.C. Area

With close cooperation between the American Hungarian Federation (AHF), the American Hungarian Heritage House and the Hungarian Scouts of Washington, a Hungarian Charity Ball has been held yearly since 2005 in the U.S. capital to support educational and charitable programs both in the United States and throughout the Hungarian communities in the Carpathian Basin. Coalition leaders and interns have sponsored and attended this event multiple times to show their support.


Here are some highlights from past conferences between 2012–2022:

Daytona Beach, FL-Hungarian Summit

In May 2022, the Coalition partnered with HungarianHub to lead the community track at the Inaugural Hungarian Summit held in Daytona Beach, FL. The 3-day conference was an unprecedented gathering of Hungarian and American leaders in business, culture, sports, art, community and education. The Summit was created by Piros Pazaurek, founder of HungarianHub and Coalition Board member. The community track, led by Coalition President Andrea Lauer Rice, was in many ways a continuation of the HATOG (Hungarian Americans TOGether) conference series, organized by the Coalition over the past 15 years.

Washington D.C.

The Hungarian Americans Together Conference X took place in the Washington D.C., area in May 2017. There were more than 60 attendees, representing 16 states and Hungary. The conference was co-organized by the American Hungarian Heritage House (AHHH), the Coalition, and The Hungary Initiatives Foundation (HIF), which provided funding for the conference. Members of the organizing committee included HAC President Andrea Lauer Rice, Founders of the American Hungarian Heritage House Stefan and Erika Fedor, and HIF Executive Director Anna Smith Lacey.

Sarasota & Venice, FL

In May 2015, the Hungarian Americans Together Conference IX was held in Sarasota and Venice, FL. Participants included more than 60 attendees from 10 states and Hungary. The conference was organized by the Hungarian Christian Society (HCS)/Petofi Club, and funding for the conference was provided by a generous grant from The Hungary Initiatives Foundation. Members of the organizing committee included President of the Global Friendship Foundation Erika Klatyik, Coalition Vice President Andrea Lauer Rice, Hungarian Christian Society President Noemi Szilagyi, Leader of the Napraforgok Folk Dance Music Camp Ottilia Varga, and Kossuth Club of Sarasota Leader Eva Kisvarsanyi.

Boston, MA

The Hungarian Americans Together Conference VIII was held in late September 2014 in Boston, MA. The conference, which was organized by the Hungarian Society of Massachusetts and the Honorary Consulate General of Hungary in Boston, with support from The Hungary Initiatives Foundation and the HAC, included more than 70 participants, representing 17 states and Hungary. Funding for the conference was provided by a generous grant from The Hungary Initiatives Foundation, and members of the organizing committee included Dr. Agnes Virga, Honorary Consul Gabor Garai and HAC Vice President Andrea Lauer Rice.

Atlanta, GA

In September of the same year, Southeastern members of the Coalition under the leadership of Vice President Andrea Lauer Rice organized the Hungarian Americans Together Conference VII in Atlanta, GA. The 60 participants represented 36 organizations, 12 states, and Hungary. The conference was cosponsored by the Hungary Initiatives Foundation, and participating local organizations included the Atlanta Hungarian Meetup and Honorary Consul John Parkerson.

San Francisco, CA

In early March 2013, West Coast members of the Coalition in concert with the Honorary Consulate General of Hungary in San Francisco organized the Hungarian Americans Together Conference VI. The 73 attendees represented 29 organizations, six states, and Hungary. Among the participating organizations were the Hungarian Catholic Mission, Woodside Priory and the Free Magyar Reformed Church of San Francisco and Vicinity, and the organizing committee included Honorary Consul Eva Voisin, Katalin Voros, Geza Kadar and Helen Szablya.

Dr. Charles Simonyi: Donor Impact



Technology pioneer, successful entrepreneur, dedicated philanthropist and astronaut are all terms which characterize the highly accomplished and multi-faceted Dr. Charles Simonyi.

Born in Budapest, Hungary in 1948, Simonyi's interest in computers began in high school, when he assisted an engineer working on one of only five computers in Hungary, a Russian-made Ural II. In 1967, he moved to the U.S. to study at the University of California at Berkeley, where he received his B.S. in engineering mathematics in 1972. In 1977, he completed his doctorate in computer science from Stanford University.

From 1972 to 1980, Simonyi worked at Xerox Palo Alto Research Center (PARC), the flagship research division of the Xerox Corporation, a hotbed of outstanding minds in the 1970s and incubator of many elements of modern computing. At Xerox PARC, he created the first WYSIWYG (what-you-see-is-what-you-get) text editor called Bravo.

In 1981, Simonyi joined Microsoft Corporation where he held the titles of Director of Application Development, Chief Architect and Distinguished Engineer. He oversaw the development of what became the company's most profitable products, Microsoft Word and Microsoft Excel, and introduced techniques and methods developed at PARC, including "Hungarian notation" naming conventions memorable by the strings of unpronounceable consonants that resemble his consonant-rich native tongue. Simonyi was a key player at Microsoft during its meteoric rise in the software industry, becoming one of its highest-ranking developers. He left Microsoft in August 2002 to found Intentional Software Corporation, a software engineering company, with fellow Hungarian Gregor Kiczales.

In 2003, he established the Charles Simonyi Fund for Arts and Sciences, led by Executive Director Susan Hutchison, to support arts organizations, science programs and educational institutions. Through this fund, Dr. Simonyi has partnered with the Coalition on a number of projects. Since its inception in 2005–2012, he funded the Congressional Internship Program. Dr. Simonyi worked with the Coalition to award research scholarships, and annual awards for excellence in physical sciences and technical education in Hungary from 2000-2009. Several grants to the Coalition have funded special projects, such as the rebuilding of the Town Hall of Vámosújfalu in 2001, the restoration of the 100-year-old lecture hall at Semmelweis University in Budapest in 2010. The organization was later renamed the Charles and Lisa Simonyi Fund for the Arts and Sciences.

In 2007, Simonyi became the fifth private individual to travel into space to the International Space Station. In 2009, he made a second trip.

Hungarian Diaspora Council and Hungarian Standing Conference

Since 2010 the Hungarian government's diaspora policies have undergone an unprecedented period of change and strengthening. One important step was the creation of the Hungarian Diaspora Council in 2011, which provides a forum of dialogue for representatives of the diaspora and representatives of the Hungarian government. The Hungarian Standing Conference (MÁÉRT) is a forum for regular consultations with the leaders of the Hungarian minorities within the Carpathian basin that began in 1999. Their major objective is to provide leaders from Hungarian communities in the Carpathian Basin and Hungarian diaspora organizations an opportunity to communicate and share experiences with each other and the Hungarian government.

Lauer Rice Elected U.S. President of the Hungarian Diaspora Council

In 2019, Andrea Lauer Rice, President of the Coalition, was elected U.S. President of the Hungarian Diaspora Council by her peers at the Hungarian Diaspora Council meeting in Budapest. She is the second U.S. President, succeeding László Hámos, President of the Hungarian Human Rights Foundation, who served as U.S. President from its inception in 2011 until his untimely death in 2018.

It has been a true honor to represent our diverse and talented Hungarian American community to Hungary. In many ways, it is an extension of my work with the Coalition, finding ways to highlight, strengthen and support projects within the Hungarian American community and build bridges to Hungary and the Carpathian Basin.

In 2020, in her first year as the U.S. President of the Hungarian Diaspora Council, Lauer Rice developed a number of new approaches to address changes in community work as everyone battled the pandemic. She hosted monthly community update calls in both English and Hungarian with more than 50 community leaders to keep everyone informed and unified. She gave welcoming remarks at many virtual events: the first virtual American Hungarian Schools Association (AMIT) conference; the Hungarian (Magyar) Club of Chicago's Gala Ball; the Minnesota Hungarians' 1956 Commemoration; the Hungarian Heritage Foundation of Southern California's 100th Trianon Remembrance program; the Hungarian American Cultural Association's (HACA) Monthly Happy Hour; the Hungarian Communion of Friend's Itt Ott; the American Hungarian Foundation's 1956 Commemoration; virtual theatre sessions organized by member organizations HungarianHub and the Hungarian House of New York; and a three-part series on Trianon organized by the Cleveland Hungarian Heritage Society.

Below are some highlights of the Coalition's Involvement:

2022 The annual Diaspora Council meeting was decreased in size from approximately 100 global representatives to allowing only one representative per country, while the other representatives joined online. As representative for the Hungarian American community, Andrea Lauer Rice prepared a 6-minute compilation video of activities from across the U.S. and presented it to those in person and online.

2020 Attended the virtual 10th Annual Diaspora Council meeting on November 26, 2020. The Coalition was represented by U.S. President of the Diaspora Council and HAC President Andrea Lauer Rice, who delivered a five-minute speech about the Hungarian-American community's past year. Several other Coalition members were present: Zsolt Szekeres, Hungarian Human Rights Foundation; Eva Beluska, Metroplex Hungarian Cultural Circle; Endre Szentkirályi, United Hungarian Societies in Cleveland; Hajnal Minger, Hungarian Communion of Friends; Ildikó Nagy, Hungarian House of New York; Csilla Grauzer, Minnesota Hungarians; Lívia Rácz, Hungarian Society of Massachusetts; and Stefan Fedor, American Hungarian Heritage House. Earlier the same day, Lauer Rice and the other regional presidents were invited to attend the virtual Hungarian Standing Conference (MÁÉRT) to meet Hungarians from all over the world and representatives of Hungarian political parties.

2019 Attended the 9th Annual Diaspora Council meeting on November 14, 2019, in Budapest at the Hungarian Castle Gardens. More than 90 leaders and representatives of organizations from 32 countries participated, including 18 Hungarian American attendees, many of which were Coalition members.

Andrea Lauer Rice, President of the Coalition, was elected U.S. President of the Diaspora Council for a two-year term. The day after the Diaspora Council meeting, on November 15, 2019, Andrea Lauer Rice and the other regional presidents attended the Hungarian Standing Conference (MÁÉRT) to meet Hungarians from all over the world and representatives of all Hungarian political parties.

2018 Attended the 8th Annual Diaspora Council meeting on November 15, 2018, in Budapest at the Hungarian Castle Gardens. More than 70 leaders and representatives of organizations from around the world participated, including over 20 Hungarian American attendees, many of which were Coalition members. The Coalition was represented by Andrea Lauer Rice.

2017 Attended the 7th Annual Diaspora Council meeting on November 9, 2017, in Budapest at the Hungarian Castle Gardens. More than 70 leaders and representatives of organizations from around the world participated, including over 25 Hungarian American attendees, many of which were Coalition members. The Coalition was represented by President Andrea Lauer Rice.

2016 Attended the 6th Annual Diaspora Council meeting on November 30, 2016, in Budapest at the Hungarian Castle Gardens. More than 70 leaders and representatives of organizations from around the world participated, including over 25 Hungarian American attendees, many of which were HAC members. HAC was represented by HAC Chairman of the Board Éva E. Voisin.

2015 Attended the 5th Annual Diaspora Council meeting on December 2, 2015, in Budapest at the Hungarian Castle Gardens. More than 70 leaders and representatives of organizations from around the world participated, including over 25 Hungarian American attendees, many of which were Coalition members. Regional Diaspora Meetings

Since 2016, Regional Diaspora Meetings have been held in different Consular Districts across the U.S., organized by the Hungarian Embassy and Consulates. Hungarian American organizations participate in day-long discussions on projects, challenges and shaping the future of the Hungarian diaspora in the U.S. Here are some highlights from past meetings in which HAC members participated:

In D.C., Special Commissioner to the Prime Minister of Hungary Katalin Szili spoke about the importance of autonomy for Hungarians living in minority in the Carpathian Basin, as well as the critical link between Hungarians living in the diaspora and those living as ethnic minorities. Approximately 40 Hungarian American community leaders attended the conference, including HAC President Andrea Lauer Rice, Vice President Stefan Fedor, and other HAC members. Károly Pánczél, member of the National Assembly (MP) for Ráckeve (Pest County Constituency XIII), attended the Cleveland meeting with about 25 leaders from across Ohio, including HAC Chair Emerita Edith K Lauer and then Vice President Endre Szentkirályi.

2018 Attended the Third Regional Diaspora Meeting on May 19, 2018, hosted by Ambassador Dr. László Szabó at the Embassy of Hungary in Washington D.C. Approximately 40 Hungarian American community leaders attended the conference, representing organizations based in the South and the Washington D.C., area. After the meeting, HAC President Andrea Lauer Rice attended the annual Hungarian Charity Ball, organized by the American Hungarian Heritage House, a Coalition member organization.

2017 Attended the Second Regional Diaspora Meeting on March 11, 2017, hosted by Ambassador Réka Szemerkényi at the Embassy of Hungary in Washington D.C. Approximately 40 Hungarian-American community leaders attended the conference, representing organizations based in the South and the Washington D.C., area.



John N. & Edith K. Lauer: Donor Impact

(† John N. Lauer-February 19, 1942-February 21, 2018)



Edith K. Lauer fled Hungary with her family in 1956 after she witnessed the Hungarian Revolution and settled in Silver Spring, MD. John N. Lauer grew up in Hyattsville, MD. They met at University of Maryland and married soon after. John received a B.S. degree in chemical engineering from the University of Maryland, College Park, and an MBA from Texas A&M University, Kingsville, TX. Edith earned B.S. and M.A. degrees in English and Spanish from Texas A&M. Together, they had two daughters, Kriszta and Andrea and two grandsons, Miklos and Janoska.

John had a long and distinguished business career. From 2005–2013, he served as non-executive Chairman of the Board for Diebold, Inc. He is former Chairman, President and CEO of Oglebay Norton Company, Cleveland, OH. Prior to Oglebay, Lauer served as President and COO of the B.F. Goodrich Company. He began his career at Celanese Corp. and was a top executive in 1987 when it was bought by the German Hoechst Company.

John and Edith were first introduced to the Hungarian American community in the mid-1980s, when they worked with Lászlo Hámos and Zsolt Szekeres to create a historically successful fundraiser with Barron Thyssen Bornemissza for the Hungarian Human Rights Foundation. In 1991, after the Iron Curtain fell and democracy returned to her homeland, Edith helped found the Hungarian American Coalition. From its inception, they were avid supporters. Over the years, Edith served as President, Chairman and eventually Chair Emerita, spearheading many major Coalition initiatives: such as NATO Advocacy, human rights advocacy programs across the Carpathian Basin and the Coalition's scholarship and internship programs.

"Since the Coalition's founding, I have been an avid and enthusiastic supporter of the mission and many of the excellent projects of this organization. With interest and pride, I have encouraged the efforts of my wife Edith and daughter Andrea as they have actively participated in HAC's many accomplishments, which have positively changed numerous lives in the Carpathian Basin, in the Hungarian American community, and, on occasion, have been able to inform government policies and direction. The Lauer Family's Pannonius Foundation was created and supported such projects as the "Godparents' Program" for the Reformed Kollégium of Kolozsvár, Madách Posonium Publishers and the Posonium Literary Awards in Slovakia, which they presented for 10 years.

John accompanied Edith on dozens of trips throughout the region, especially to Transylvania, Kolozsvár (Cluj-Napoca). Through the "Godchildren" program, the Lauers sponsored dozens of students and even provided partial university scholarships to help them complete their degrees. They also traveled often to Pozsony (Bratislava), Slovakia, to visit Laszlo and Eva Dobos and Madách Publishers, where they awarded for ten years, the annual Posonium Literary Awards to Hungarian authors.

John was recognized in 2014 with the Hungarian American Coalition Award. Edith has been presented with multiple awards for her work over the years in the Hungarian community, including the Officer's Cross of the Order of Merit from the Republic of Hungary. The Lauers have been some of the most active and generous supporters of the Coalition since its founding in 1991. Sadly, John passed away in 2018, but Edith's generous support of the Coalition and scholarship programs continues. She also serves on the Boards of the Hungary Foundation and Victims of Communism Memorial Foundation.

Organizations

American Hungarian Catholic Clergy Association—Apostolate to Hungarians (Fr. Barnabás G. Kiss, OFM)

The American Hungarian Catholic Clergy Association, established in 1974, provides its members with the opportunity for fellowship and cooperation, while identifying the goals of Hungarian pastoral work and enabling the Hungarian clergy in the U.S. to remain faithful to their language and religious traditions. (1991-present)

American Hungarian Foundation (Melissa Katkó Pepin) Founded in 1954, the American Hungarian Foundation is devoted to furthering the understanding and appreciation of the Hungarian cultural and historical heritage in the United States. The Foundation serves as a bridge between Hungarian and American cultural traditions in an effort to enhance a better understanding of the contributions of each. Its extensive Museum and Library are housed in a redesigned bakery in New Brunswick. Its exhibits and frequent programs provide an insight into the finest traditions of Hungarian culture and art. (1991–93, 2006–present)

Calvin Synod of the United Church of Christ (Rev. Dr. Csaba Krasznai) Organized in 1939 as a Synod of the Evangelical and Reformed Church the Calvin Synod contains 41 congregations that constitute 4 classes (Eastern, Central, Lakeside and Western). The Eastern Classis was organized in 1896 and is considered to be the oldest Hungarian Reformed Church entity outside of Hungary. In addition to serving its parishioners' spiritual needs, the Synod provides extensive financial assistance to churches and educational institutions in Hungary and the Carpathian Basin. (1991-present)

Civic Enterprises, Budapest (Márton Aichelburg) The first programs established by Civic Enterprises are their Senior Mentor Programs in Hungary and Slovakia. They match volunteers age 55 and over to tutor and mentor elementary school students struggling to learn to read. These programs boost student academic performance, help schools become more successful and establish close bonds between tutors and students. (2014-present)

Cleveland Hungarian Heritage Society (Eva Suzanne Szabo) Founded in 1985, the mission of the Cleveland Hungarian Heritage Society is to preserve Hungarian culture and the history of Hungarians in Northeast Ohio, so that present and future generations can draw upon its collection for education, inspiration and enrichment. Its Museum in downtown Cleveland houses both permanent and temporary exhibits. It provides educational programs and the opportunity for research in its excellent library, and it operates a Gift Shop filled with Hungarian books, collectibles and gift items. (2001-present)

Hungarian (Magyar) Club of Chicago (Andrea Stetz) Established 100 years ago, the Hungarian Club of Chicago is one of the strongest Hungarian American organizations in the Midwest. The Club promotes Hungarian traditions and culture; it celebrates Hungarian national holidays; participates in and supports Hungarian churches and other organizations in Chicago. One of the most important permanent charitable activities of the Club is its own Scholarship Program, which is the only financial support organization for educational purposes aimed at American Hungarian undergraduate and graduate students in the entire Midwest region. (1994-present)

Hungarian Communion of Friends (Dr. Erika Bokor) Established in 1967, the Hungarian Communion of Friends (Magyar Baráti Közösség) is the organization known for its annual, week-long conference, Itt Ott (Here and There), held at Lake Hope State Park in Ohio. Before 1990, it provided a much-needed forum for famous writers and opposition politicians from Hungary and the neighboring countries. Its annual publication, entitled Itt-Ott, provides a public forum for various topics, including the content of the year's conference and questions related to Hungarians living outside the borders of Hungary. The organization has also funded scholarships and various projects in Hungarian inhabited areas of Romania and the neighboring countries. (1991-present)

HungarianHub (Piros Pazaurek) HungarianHub founder Piros Pazaurek's mission is to maintain the unity of the Hungarian community and to preserve strong intellectual values. She believes in the power of quality events that strengthen not only the Hungarian community's identity, but also helps to deepen the positive image of Hungarians at a local level. HungarianHub.com is a resource to further the collaboration and investment between Hungary and the U.S., and it aims to promote cultural appreciation and economic growth. (2019-present)

Hungarian Human Rights Foundation (Emese Latkóczy) Since 1976, the Hungarian Human Rights Foundation (HHRF) has been monitoring the human rights condition of the nearly three million Hungarians who live as minorities in the countries surrounding Hungary. In accordance with its purpose, HHRF regularly collects, translates, analyzes and disseminates reliable reports on the human rights conditions of these Hungarian minority communities. HHRF has an extensive internship program and has offices in Brussels, Budapest and Kolozsvár (Cluj-Napoca), Romania. (1991-present)

Hungarian Scout Association in Exteris (Irén Dala) The Hungarian Scouts trace their origins to 1946, when a few dedicated scout leaders, refugees from war-torn Hungary, formed the first exile troops among the children in European refugee camps. With the ensuing emigration, the movement spread overseas and today counts a total of 5,049 members (boys, girls and adults) registered in 81 active troops in Western Europe, North and South America, and Australia. The goal of the Association has been to preserve and pass on to the scouts Hungarian culture and language while practicing the historically high standards of Hungarian scouting, and to represent Hungary in world scouting. (1991-present)

Hungarian Society of Massachusetts (János Perge) Founded in 1964, the Hungarian Society of Massachusetts, Inc. is a non-profit, cultural organization that disassociates itself from partisan politics. Membership is open to individuals of all ideologies, religions and ethnic backgrounds who abide by the Society's by-laws, and who desire to foster the Hungarian language and culture. In the mid-1960's the Society established a weekend school where volunteers taught 20–30 Hungarian children to read and write in Hungarian. In 2000, the school was reestablished as the Béla Bartók Hungarian School of Boston (Boskola), who are often also members of the Society's sizeable Scout troop. (2011-present)

Kossuth Foundation (Dr. Sándor Végh) The mission of the Foundation is to, "foster diversity in American society and honor the presence of Hungarian Americans in it by maintaining and encouraging the language, heritage, religious traditions, and historical culture of Hungarians in America and the appreciation thereof." (2012-present)

Minnesota Hungarians (Csilla Grauzer) The mission of Minnesota Hungarians is to nurture the Hungarian cultural heritage of its members; to represent it in American society and academia; to participate in the activities of other Hungarian-American organizations; and to organize Hungarian cultural and social programs. The group often welcomes Hungarian visitors and newcomers to Minnesota and assists them with local information and services. They also help Hungarian groups and individuals with their needs, and facilitate exchange programs of professionals with Hungary. Their charitable programs include scholarships and other assistance to Hungarian students in the Carpathian Basin. (1992-present)

Seattle-Pécs Sister Cities Association/Hungarian American Association of Washington (Dániel Takács)

The Seattle-Pécs Sister Cities Association was founded in 1991, and is composed of individuals and organizations interested in promoting close ties between the people of Seattle, Washington State, and Pécs, Hungary. Its goals are to advance educational, cultural and commercial relations between both cities, and inform and educate the public about their sister city. The Hungarian American Association of Washington is a non-profit organization dedicated to preserving Hungarian heritage and to creating

better understanding and appreciation of the Hungarian culture in the community. Founded in 1984, the Association serves people of Hungarian descent and those interested in Hungarian culture with educational and social events. (1996-present)

The Bethlen Communities The Bethlen Communities in Ligonier, Pennsylvania, is one of the oldest Hungarian organizations to have joined the Hungarian American Coalition. Founded in 1921 as a residence for orphans, it evolved into a home for the aged, with a capacity of over 100 beds and twenty retirement cottages. The Bethlen Home is a church-related, nonprofit subsidiary of the Hungarian Reformed Federation of America. (1991-present)

William Penn Association (Richard E. Sarosi) WPA, founded 125 years ago, is a Hungarian-American Fraternal Benefit Society serving the Hungarian American community. The Association operates on a non-profit basis providing life insurance and annuities to its members. The Association conducts fraternal and charitable activities for the benefit of their membership, including awarding a large number of Univ. scholarships to the children of policyholders. WPA has a distinguished record of promoting Hungarian cultural heritage in the U.S. by assisting Hungarian American organizations with their various projects and programs. (2006-present)

The Coalition's current organizational members who are not members of the Board:

American Hungarian Library and Historical Society The American Hungarian Library and Historical Society, established in 1955 is one of the oldest Hungarian cultural institutions and one of the owners of the Hungarian House in New York City. The mission of the American Hungarian Library and Historical Society is to promote interest in and knowledge of Hungary, to gather and preserve books and material with historical value and make them available to the public. We also strive to be a center of Hungarian cultural programs, specifically art and literature, in New York City. (2023–present)

Béla Bartók Hungarian School of Boston (Boskola) The Béla Bartók Hungarian School of Boston (Boskola) was established in 2000 by enthusiastic parents from the Boston area. Its mission is to enrich Hungarian language skills and cultural appreciation of children between the ages of 3 and 18. Parents and Scout leaders volunteer as Boskola teachers and staff. Since its founding, the number of Boskola classes and students have grown consistently. In recent years, between 50 and 60 families with 80–90 students have regularly attended the sessions, studying in different groups according to their age and language level. (2010–present)

Carpathian Foundation—Hungary The mission of the Carpathian Foundation—Hungary is to improve the quality of life of people living in the Carpathian Euro-region, and to preserve the social, ethnic, cultural and environmental values and sustainable development of the region. The Foundation acts as a cross-border regional community foundation and primarily provides financial and technical assistance to NGOs and LSGs (local-self-governments) operating in the Hungarian part of the Carpathian Euroregion (Borsod-Abaúj-Zemplén, Hajdú-Bihar, Heves, Jász-Nagykun-Szolnok, and Szabolcs-Szatmár-Bereg counties). (2014–present)

Creative Cultural Exchange Inc. Creative Cultural Exchange, Inc. (CCE) a 501(c) organization committed to promoting innovative cross-cultural dialogue, collaboration and development between the United States, Hungary and other countries in Central and Eastern Europe. CCE's goal is to foster a deeper understanding of our diverse cultures while highlighting our shared humanity. (2018–present)

Hungarian Association This cultural organization, founded in 1952, has held its traditional Congress in Cleveland, OH each November since 1961. The 4-day meeting provides a forum for lectures by invited speakers in the U.S. and the Carpathian Basin on educational, historic, literary, and artistic issues that impact Hungarian Americans. The Association publishes its annual Chronicle while the Árpád Academy honors outstanding Hungarian Americans. (2010-present)

Hungarian Culture Club The Hungarian Club was incorporated in May of 1935 as a Social Club for members of Hungarian descent. They are located in a 1-square mile town called Fairport Harbor, on the banks of Lake Erie. Many of the residents of their town immigrated here from Hungary in the 1930's in search of work and settled here with their families. The town currently has about 3,500 residents, with the majority of them being of Hungarian and Finnish descent. The Hungarian Culture Club sits on the banks of the Grand River near the mouth of Lake Erie. (2023–present)

Hungarian Cultural Center of Northeastern Ohio The Geauga Magyar Cultural Society and St. Stephens Magyar Drama Club, both of which promoted Hungarian culture and customs in Ohio, merged to create the Hungarian Cultural Center of Northeastern Ohio (HCC-NEO). The organization holds picnics, celebrations and a Harvest Festival on its 40 acre property in Hiram. They co-sponsor and coordinate their programs with other Hungarian organizations in Cleveland. In 2006 they built a lovely traditional Székely kapu (wooden carved gate from Transylvania). (2019-present)

Metroplex Magyar Cultural Circle The Metroplex Magyar Cultural Circle was founded for the promotion and preservation of the Hungarian culture, language, and traditions in the north Texas area. There is also the long term goal of establishing a "Magyar Ház", or Hungarian Club House in the North Texas Metroplex for celebrations, Hungarian cooking and housing their film, book, and music library. (2016–present)

St. Stephen of Hungary Catholic Community The Hungarian community of the Washington Metropolitan Area, because of its proximity to the Capital, holds a historically significant position in Hungarian immigration for its ability to represent Hungary's interests. In August, 2015 a Hungarian National Chapel was consecrated at the Basilica of the National Shrine of the Immaculate Conception, where their monthly masses are held. This much anticipated new milestone presents a new spiritual home to Hungarian Catholics in the region as well as all over the world. (2018 -present)

Széll Kálmán Foundation, Budapest Founded in 2003, as a membership of almost 300 economic and corporate leaders and intellectuals who share a values-based commitment to Hungarian society. The Foundation's goals include the continuous monitoring of the state of the Hungarian economy, the organizing of lectures on the economic and social situation of the world and the European Union in particular, as well as on the effects of these on the Hungarian economy, and the organizing of events, professional forums and discussions to improve the economic situation of Hungary and Hungarian enterprises. (2010-present)




Income
